

What Your Currency Is Worth Against Other Currencies.

How to read table:

The Horizontal row gives the amount of another currency for the currencies listed down the left hand side.

eg; For \$1.00 Australian you will get **28.34** baht.

The Vertical columns give the value of another currency in your chosen currency. eg; 10 baht is worth **35** cents Australian.

and conditions of the sale.

At the next meeting, all parties will sign the S&P agreement and any other documents included in the deal, and the payment for the purchase will be handed over to the seller. Then buyer and seller go to the land office to register the sale and transfer. It is at this stage that some buyers experience some worry, because they don't actually get the land title deed straight

away. In some land offices it can take 24 hours to process, but in others it may take up to a week. However, the buyer need have no worries. Once both parties have signed the S&P agreement in front of witnesses, and they have registered the sale with the land office, the deal is set in concrete and each party is legally committed.

In my next article, I will discuss the moral and legal obligations of the agent.
